Masters Swim Clubs Sanction Application Guide

(Revised May 14, 2010)

Before the Meet:

1. Develop Meet Information Package (this should be done 8-10 wks prior to date of meet).

Note: ALL meet entries must be accompanied by the swimmer's registration number. Please remember to put this in your meet package. If entries are received without a registration number then the entries are to be rejected and sent back to the swimmer or club and advise them that the proper swimmer registration number is required.

2. Complete the attached Swim Sask Sanction Form and Pool Depth Declaration Form. The Pool Depth Declaration form is to be faxed to Marni Caldwell at: 585-1431. The Completed sanction form is to be sent to Marni electronically and emailed to her.
3. Email completed sanction form and Meet Information Package, **no later than 5 weeks** prior to your meet, to Sanction chairperson Marni Caldwell at: beancounter1@accesscomm.ca

NOTE: Meet packages will not be sanctioned until the signed copy of the Pool Depth Declaration Form is received. Clubs need to complete only one per year, for each pool that they may hold a competition in.

4. Once the meet package has been approved and you have received a Sanction Number, then you may send a copy of the meet information out to clubs. The sanctioned meet package will also be posted on the Swim Sask website

Meet packages should be sent out to clubs approx. 4 - 6 weeks prior to the date of your meet.

After the Meet: - Meet Manager is responsible to ensure that all the following must be done within 14 days upon completion of the meet:

1. Forward a copy of the sanction form, with appropriate meet assessment fees **and** a print out of the Hytek Meet Manager Team Entry Fee Report OR Team List Report to:

I/We have reviewed the safety standards as outlined in the Swimming/Natation Canada Rule Book specifically Appendix B Rules FR 2.3 **and** CFR 2.3.1 as well as Rule FR 2.7 which all speak specifically to legal depth of water at starting end of pool and the legal size and height of the starting blocks.

FR 2.7 The height of the starting platform above the water surface shall be from 0.5 metre to 0.75 metre. The platform surface shall be at least 0.5 metre x 0.5 metre.

This facility meets the required standards outlined in Rule FR 2.7.

Please check ONLY 1 of the following, whichever applies to your pool

FR 2.3 **"The water depth for a distance of 1.0 metre to 6.0 metres from the end wall must be at least 1.35 metres where starting platforms are installed.**

This facility meets the required standards outlined in Rule FR 2.3

CFR 2.3.1 **"The water depth for a distance of 1.0 metre to 5.0 metres from the end wall must be at least 1.2 metres where starting platforms are installed."**
